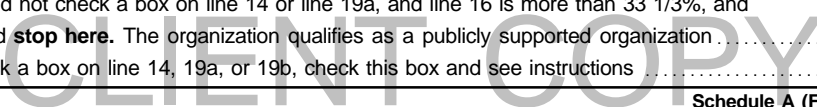

THE SUPPORT FROM THE FOUNDATION TO LSD IS PROPERLY REFLECTED IN THE STATEMENT OF ACTIVITIES AS OPERATIONS EXPENSE. FOR THE YEAR ENDED JUNE 30, 2023, THE TOTAL COMPENSATION PACKAGE AMOUNTED TO \$12,862. THE FOUNDATION REIMBURSED THE SCHOOL DISTRICT FOR THE SALARIES PORTION OF THE COMPENSATION PACKAGE IN THE AMOUNT OF \$9,000 FOR THE SAME FISCAL YEAR.
